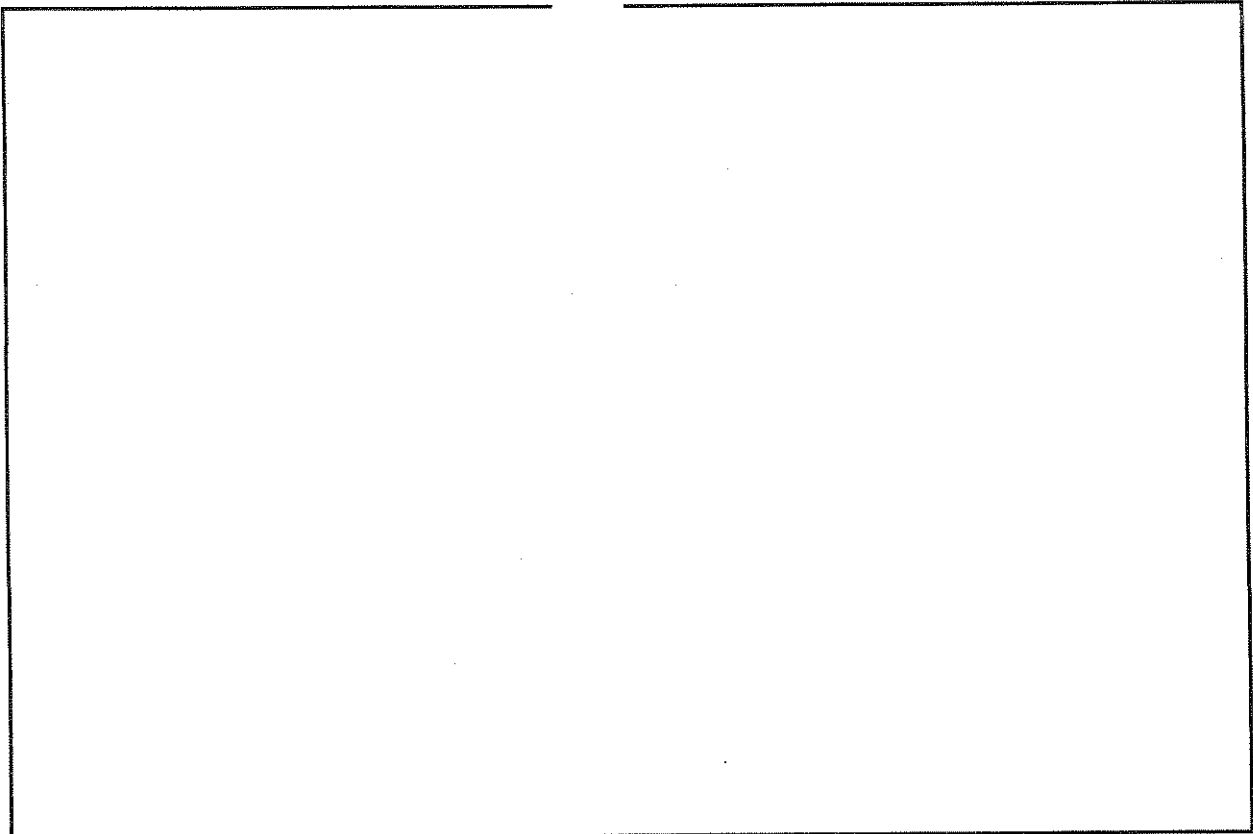

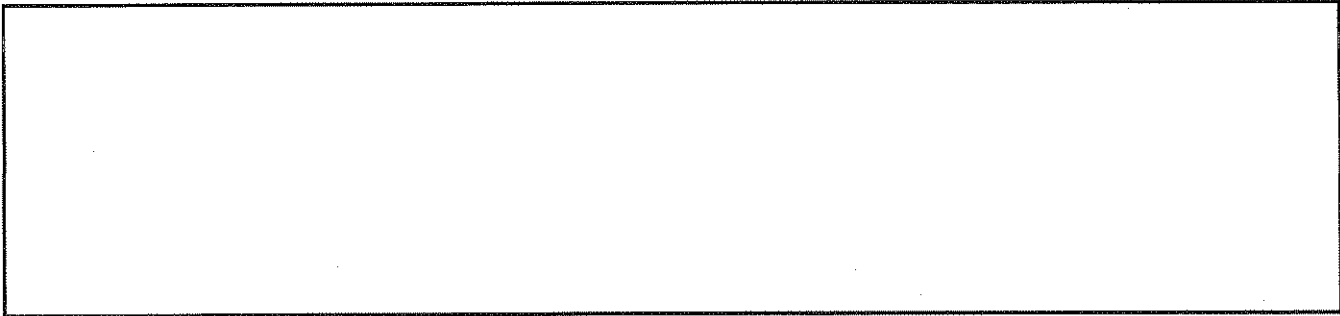

Towards the end of the document, it says: "Finally, it is commonly believed that ELF and ALF are funded by more mainstream, generally law-abiding groups, such as People for the Ethical Treatment of Animals and In Defense of Animals." Using the phrase "it is commonly believed" is very odd in this context. If evidence exists linking PETA and IDA to ELF/ALF, then the sentence should be rephrased accordingly. If such evidence does not exist or is weak, then PETA and IDA should not be mentioned in the sentence. Otherwise, the statement perjoratively associates the two groups with law breakers on the basis of "common beliefs."

I received a telephone call and a fax from Philadelphia Division, State College RA (SCOLRA) advising of the following information:

During the week of April 18 through 20, 2005 a spokesperson for PETA, Loring Harkness, will present at a lecture at the request of the Alliance for Animal Rights (AAR) at Penn State University. Harkness will lecture on April 18, 2005 and April 20, 2005. [Redacted] The AAR is a registered PSU Student Organization sanctioned and funded by the University. The AAR has in the recent past performed Legal Protest against the Zola's Restaurant, Kentucky Fried Chicken as well as circuses.

Of interest, during the week of April 14 through April 17, 2005, the Ringling Brothers Circus will be at the Jordan Center in State College, Pennsylvania. On April 16, 2005, PSU will host the Little International Livestock Exhibition and the Penn State Dairy Exposition. These dates also coincide with WWAIL.

SCOLRA has notified the local and state law enforcement as well as PSU University Police. All involved have decided to make appropriate notifications to local farms and any identified possible targets; providing information to public relations officials at PSU, as well as other affected entities; and an increase in covert law enforcement activity in the area.

SCOLRA is aware that PETA is a legal organization exercising its first amendment rights and has articulated same to local law enforcement entities. SCOLRA will not conduct investigation into this gathering unless attendees engage in criminal activity.

I don't know if this rises to the level of the daily brief, but I wanted to pass it on for information:

SA [redacted] FBI Tampa, called me today (8/20/2003) to tell me that Tampa is monitoring the arrival of some elephants from Swaziland (a small nation near South Africa). Swaziland is exporting 11 elephants to the United States. The elephants are being loaded onto a 747 jumbo jet and arriving in Tampa at 8:30 p.m. on 8/21. Four of the elephants will be off-loaded in Tampa, and the rest of the elephants (7) will continue on to San Diego, where they will be housed in the San Diego Zoo. Tentatively, on 08/21/2003 at appx. 2030, eleven (11) African elephants from Swaziland, Africa will be imported and transported to the Lowry Park Zoo (4 elephants), and the San Diego Zoo Wild Animal Park (7 elephants). The elephants will be crated and flown via CargoLux cargo 747 to the Tampa International Airport where they will all clear Customs, Agriculture, and Fish and Wildlife requirements. Four will be off-loaded and transported to the Lowry Park Zoo. The aircraft will be refueled and continue on to San Diego, California, arriving at either March GlobalPort, March AFB, California (preferred), or San Diego Lindbergh International Airport, San Diego, California, and the remaining seven elephants transported to the Wild Animal Park, Escondido, California. Arrival dates and times continue to be fluid, and could change. It is known that PETA has informants in various zoos and other wildlife organizations.

Last week, there was an incident at the Lowry Park Zoo in which three PETA activists were arrested after they caused a ruckus at the zoo. They went into a building where they were not authorized access and started screaming "Born Free, Live Free!" They were arrested and charged with burglary but most likely, the charges will be reduced to trespassing. FIs revealed that several of the PETA protestors traveled from out of town. One of those arrested was actually employed by PETA as an "organizer" from Norfolk. There was also a minor disturbance at Lowry last Saturday.

Intell indicates that the PETA out of towners have left, however, TPD is taking the transport and security of the elephants very seriously. TPD will have a special responses team at the zoo to deal with any civil disturbance issues, i.e. chaining self to fences, bicycle locking necks to stationary objects etc. There will be a TPD escort of the elephants from TIA to the zoo. If the plane lands on time at 2030, my best guess is a midnight convoy movement. The TIA police will also be stepping up security measures during this operation. [Redacted] TPD is a member of the JTTF and is the POC for TPD. SA [Redacted] airport liaison, will be on hand when they arrive. Yesterday, there was a meeting involving FBI, TPD and TIA POCs at TPD HQ, and we hashed out all the issues. We will continue to coordinate with San Diego regarding any new threats.
